Fuel Surcharge Program

The RJ Corman Derailment Services fuel surcharge is based on the DOE Average Monthly On-Highway Diesel Price weighted for RJC divisions in each of the following regions:

Central Atlantic, Lower Atlantic, Midwest, Gulf Coast, Rocky Mountain & West

Surcharge will be re-calculated each month according to the most recent published U.S. Department of Energy on-highway diesel prices posted at the beginning of each month (see www.eia.doe.gov). Example: the DOE price for the month of July will determine the fuel surcharge applied throughout the month of September.

When the weighted average equals or exceeds \$1.75 per gallon, a surcharge beginning at 1.5% will apply to the billed rate for all equipment. Fuel surcharge will be applied to equipment only.

For every \$0.05 increase above \$1.75 per gallon, the surcharge will increase by 0.5%. When the weighted average drops below \$1.75, no surcharge will apply. See schedule below for more details.

Fuel surcharge will be applied to Equipment Charges. An entire job will be charged the same fuel surcharge from the first day of a job.
